- 194/18 PLANNING 194/18.1. Application for a lawful development certificate for the existing use of land as a caravan site with no limitations on numbers, type or occupancy at Whitecote Caravan Park, Ryther Road, Ulleskelf This application was considered by the Parish Council and it was agreed to submit the following objections:
 - 1. The existing planning consent does not allow for an unlimited number of static caravans on the site.
 - 2. Static caravans, unlike touring caravans, put additional stress onto the existing infrastructure as they need to be attached to the main sewerage system.
 - 3. The existing planning consent also does not allow for no limitation on occupancy a suggested by the applicant. Use of the static caravans for long-term residential use would be a material change of use as it would put further strain on the existing infrastructure, such as schools and medical services.
 - 4. The Parish Council do not consider that this site is suitable for long-term residential use. It is in close proximity to the site where residential development was refused under application 2016/0309/OUT and therefore the reasons given for this refusal would also apply to this site.
 - 5. The Parish Council also do not consider the site suitable for residential use because it does not have a footpath linking it to the village and residents would have to walk along and cross a road with a blind bend to access the village and its facilities.
 - 6. The applicant states that the site is in flood risk zone 1, however this is incorrect as the Environment Agency flood map shows that part of the site is in flood risk zone 2 and therefore a full flood risk assessment should be carried out.
 - 7. The proposed use of the site for residential use represents a material change of use that must be assessed against the relevant Core Strategy policies including SP11 for traveller's sites.

Action: Clerk to submit comments by 18th December.

Councillor Glyn reported that she has spoken to Mark Butler from Samuel Smith Old Brewery, Tadcaster about the application, who agreed to ask their planning team to look at it. **Action:** Flyer to be prepared to let residents know about the application and how to respond.
