- **MINUTES OF THE LAST MEETING** The minutes of the meeting held on 11th March 2021 were approved as a true record. They will be signed at the next physical meeting of the Council.
- **Clerks Report 192/21 Streetlights –** The Parish Council were advised that the two street lights on West End should be replaced around Easter time. They have not yet been done. <u>Action:</u> Clerk to chase
