- **MINUTES OF THE LAST MEETING** The minutes of the meeting held on 10th June 2021 were approved as a true record.
- 67/22 Clerks Report 192/21 Streetlights LP38, LP39 are now working but the old ones have not yet been removed and LP31 has not yet been connected. Work has not yet started on the replacement of LP41.
  - 205/21 Sewer complaint A meeting was held with Yorkshire Water and assurance was provided that no unsealed manholes will be sealed. The raised manhole in West End, requires repointing to prevent large ingress of water into the system overwhelming the Pumphouse. This is sealed but the concrete base below the seal has come away so will need to be repaired. Only the sewers at West End have been surveyed so far and the main village sewer survey will take place in the near future. Yorkshire Water are aware that there is a crossover of waste and surface water somewhere between the Shop and Intake Farm but are not sure how to proceed with this matter yet. The flaps on the outlet pipes into the dyke are not inspected on a 6-monthly basis. <a href="Action: Clerk to request an update before the next meeting.">Action: Clerk to request an update before the next meeting.</a>
  - **206/21 Cherry Tree Drain** The application for funding has not yet been approved as their as the Environment Agency have some concerns.

The Saturday Socials will resume on 11<sup>th</sup> September from 10am to noon and the Bonfire Night has provisionally planned for 5<sup>th</sup> November and the Carol Signing on the weekend of 18<sup>th</sup> 19<sup>th</sup> December.
